## Philadelphia Food Policy Advisory Council (FPAC) **Letter of Support for Fair Workweek Legislation**October 29th, 2018

Dear Mayor Kenney,

The Philadelphia Food Policy Advisory Council (FPAC) urges you to support the Fair Workweek legislation to support workers across Philadelphia.

FPAC convenes community members, local organizations, and institutions who work within different areas of the food system. As a body, we inform the Administration on how to be a good partner in this work to craft policies that reflect the shared values of Philadelphians. FPAC's Workforce & Economic Development subcommittee guides the City in developing and implementing policies and practices to build a stronger regional economy and just food system in which workers along the entire food chain enjoy quality jobs that provide economic stability and upward mobility. We foster collaboration-building to further these good food policies.

We know that Philadelphia is the largest poor city in the United States.¹ We know that Philadelphia employs at least 130,000 low-wage workers² who lack protections and deal with unsafe working conditions on a daily basis, resulting in negative social impacts on individuals, families, and the city at large. These are not coincidences. As the power of employees to organize and work collectively continue to be undermined at the federal and state levels, the City of Philadelphia has the opportunity to support these workers in ways that ensure fair wages and scheduling, two of the primary points of negotiation between employer and employee. All Philadelphians should have the opportunity to find gainful employment with a stable schedule, key factors that determine a healthy or unhealthy work environment.

We support Fair Workweek legislation so that Philadelphians can have:

- 1. Good faith estimates of schedules;
- 2. Advance notice of hours and schedules;
- 3. Adequate rest between shifts;
- 4. Right to request flexible working arrangements; and
- 5. Opportunity for full-time work.
